TRADING TERMS

Please read this page carefully. When you book your holiday accommodation through Slovenia**holidaycottages.com** you are entering into a contract to rent/ hire your holiday accommodation direct from the Apartment owner/s (referred to as the owner from here on in) which will bind you, the owner and us in various ways. Slovenia**holidaycottages.com** is the reservation agent for and on behalf of the owner.

MAKING A RESERVATION

Our system enables you to view your selected holiday accommodation, Complete the "I would like to rent an Apartment" form and email to us, for its availability to hire. You may then RESERVE your selected property if available, for specific dates. (Subject to the Booking Terms and Conditions, published for that specific property). To secure the reservation you will then be required to pay to Slovenia**holidaycottages.com** a Reservation Deposit of 10% of the total cost of the Hire period. Slovenia**holidaycottages.com** will send by email a deposit invoice, Payable in GBP. You secure the reservation by authorising PayPal or credit/debit card payment of your reservation deposit online, or by other payment methods.

Slovenia**holidaycottages.com** will send an automated confirmation email to you the client, that your selected property has been reserved for the requested dates. At which point we shall also send confirmation by email to the apartment owner that we have reserved the selected apartment on your behalf.

CLIENT DETAILS

Our confirmation email of a reservation will normally provide the following client details: The clients Name, Postal Address, Day, Date and Estimated Time of Arrival, Number of persons in the party, Phone Number, Email address and Additional/Other Requirements.

AVAILABILITY OF HOLIDAY APARTMENTS

All holiday apartments published are subject to availability. We reserve the right to change the details of, or withdraw any holiday-apartment prior to a contract coming into existence between us. Clients having reserved a property on our availability system who consequently discover that the selected accommodation is subsequently not available will be refunded the reservation deposit in full by Slovenia**holidaycottages.com**. We regret that we cannot accept any liability for any inaccuracy of availability. This is the responsibility of the apartment owner.

TERMS & PRICES

Once a reservation has been secured, Slovenia**holidaycottages.com** will issue you a voucher to be presented on arrival at the apartment reception. Payment for the balance of the published hire price, to be made in Euros to the reception on departure.

CHANGES TO YOUR HOLIDAY ACCOMODATION

THE CONTRACT
