TRADING TERMS

Please read this page carefully. When you book your activity/sports programs through sloveniaholidaycottages.com you are entering into a contract to purchase your holiday activity or activities direct from the activity provider. This will bind you, the activity provider and us in various ways. sloveniaholidaycottages.com is the reservation/booking agent for and on behalf of the activity provider.

MAKING A RESERVATION / BOOKING OF AN ACTIVITY/S

Our system enables you to view your selected holiday activity. You may then RESERVE your selected activity/activities if available, for specific dates on-line. To secure the reservation of the activity/activities you will then be required to pay to sloveniaholidaycottages.com a 10% deposit per activity and or program.

CLIENT DETAILS

Our confirmation email of a reservation will normally provide the following client details: The clients name, postal address, day, date and estimated time of arrival. Number of persons in the party, activity or activities required, phone number, Email address and additional/other requirements.

AVAILABILITY OF ACTIVITY/S

All activities published are subject to availability. We reserve the right to change the details of, or withdraw any activity prior to a contract coming into existence between us.

Clients having reserved an activity or activities who consequently discover that the selected activity or activities is or are subsequently not available will be refunded the reservation deposit/s in full by sloveniaholidaycottages.com. We regret that we cannot accept any liability for any inaccuracy of availability.

MAKING A BOOKING

Once a reservation for an activity or activities has been secured, sloveniaholidaycottages.com will contact you the client with confirmation of booking for the activity/s plus an Invoice. The amount payable will be shown on your invoice. You make a booking by authorising PayPal or credit/debit card payment of your deposit/s, on-line, or by other payment methods. When you do so, you accept on behalf of all your party the terms of these booking conditions. A binding contract between us will come into existence when we issue an invoice and activity booking acceptance.

PAYMENT OF BALANCE

The balance amount payable will be shown on your hire invoice. It must be paid at the reception of your accommodation or direct to the activity provider. We regret we cannot accept any liability if we are not notified of any inaccuracy on the hire invoice within 10 days of its receipt.
